




Material Health

Ingredients assesed down to 100 parts per million.

Achieving Silver certification, Shaw Contract Cradle to Cradle Certified ™ products have been assessed for their impacts on human health and the environment. They are certified to contain no substances known or suspected to cause cancer, birth defects, genetic damage, or reproductive harm (CMRs).

The Cradle to Cradle[®] design protocol calls for materials to be defined as technical or biological nutrients that are safe and healthy for humans and the environment. As part of the certification process, Shaw's entire supply chain has been assessed to identify every chemical in the product above 0.01%. These chemicals are then evaluated against 24 hazard endpoints for human and environmental health and given a hazard rating of Red, Yellow, or Green. Material assessments combine chemical hazard ratings, potential exposure information, and material cyclability information into an overall assessment for each material in the product.

The Cradle to Cradle™ Certified Products Program encourages the use of renewable energy and reducing carbon emissions. As core components of Shaw's sustainability strategy, we identify ways to increase the efficiency of our operations and to conserve energy and reduce our greenhouse gas emissions. In 2013, we installed one of the Southeast's largest commercial solar photovoltaic installations. Located on the roof of our carpet tile manufacturing plant in Cartersville, GA, the one megawatt system will produce 1.4 million kilowatt hours of power annually-- enough to power approximately 100 homes in Georgia each year.

In addition to water conservation efforts over the past decades, Shaw is committed to an additional 50% reduction in water intensity by 2030.
